Supplementary Regulations

Jurisdiction: Held under National Sporting Code and the Standing Regulations (Trials) Environmental Code of the Auto Cycle Union. The Standard Regulations of the South Midland Centre ACU, these supplementary regulations and any final instructions that may be issued. Open to members of constituent clubs in the ACU riding solo machines.

Entries: Entry via ACU online system, or to the Secretary of the meeting by Tuesday 22nd Oct 2024 with **entry fee of £20.00.**

Please make cheques payable to **VMCC CHILTERN SECTION** and enclose SAE or email address for results.

You will need to provide the registration number of your transportation vehicle for HS2 security purposes.

Club membership cards and ACU affiliation cards must be shown when signing on. If a non-starter it is required that you explain your absence. Failure to do so is a breach of the rules.

Medication: It is your responsibility to declare at signing on if you are taking any drugs. You may be tested.

Child Protection: The Meeting Secretary is the point of contact. (National Sporting Code 6.14)

Course: Dews Farm, Harefield, Middx, UB96JN all on private land, 4 Laps of 10 sections set out with classic machines in mind.

Expert Route "Red/ Blue" Route marking is as per TSR 18. (eligible for an award),

There will be an easier Clubman /Rigid Route "Yellow markers" (eligible for an award), plus a very easy White Route. (No awards) set out for the "occasional rider". The choice of route is up to you the rider. We want you to have a good days sport!

Awards:

The Bounds Cup

Awarded for the best performance on a separate gearbox British Four-Stroke machine on the Yellow / Clubman Route.

The Vangucci Cup

Awarded for the best performance on the Expert Route.

Helmets to be worn at all times when riding. Marking will be as in TSR22 B. (no stop).

1. I hereby declare that I have had the opportunity to read and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have been or maybe issued for the event, and agree to be bound by them..

2. I further declare that I am physically and mentally fit to take part in the event and am competent to do so.

3. I confirm that I understand the nature and type of event and the risk inherent with the sport and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organising officials.

4. I further agree that the machine as described below which I enter and compete on shall be suitable and proper for its purpose.

5. I confirm that if any part of the event takes place on a Public Highway the machine as described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that it will comply with the regulations in respect thereof.

6. I/ understand and agree that I am required to register on my arrival by signing on at the event Control not less than 30 minutes prior to the commencement of practice or first competition, whichever comes first.

Acknowledgement of the risks of motorsport. I understand that by taking part in this event I am exposed to risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU, the promoter, the organising club, the venue owner or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity. I have read the above and acknowledge that my participation in motorsport is entirely at my/our risk.


